- Presented the P&L and Balance Sheet report. A motion was made to approve the budget and seconded.
- Mike Dear presented the 2019 budget for approval. Kelly Langley made the motion to approve and Jim Weber seconded it. The 2019 budget was approved.
- Jim Weber noted that our budget has some reserves and equity that we need to look into.
- An offer of sale for \$11k for a parcel of land near the corner of Emerald Dr and US-12 is in the discussion pending confirming of LSPOA ownership, ability to sell, and appraisal of the property.
- Everyone has been processed for collection of dues for 2018. The number is lower that past years. Thanks to the association!

• Security-Jeff Bennett

- Looking for volunteers to monitor ice.
- Planning to give sticker for cars and shanty in order to easily identify residents that are fishing. Terry Taylor has offered to mock up something.
- If a resident identifies trespassers, call the local authorities so that this can be addressed.

 Thank you to John who supported Scott Burns from Somerset Township for attending meeting at the Hillsdale road commission meeting. Overspend of

- the county of \$30k on pavement is being pushed back by the township to not pay.
- In the county meeting, it was requested that the Hillsdale County Highway provide an estimate to fix the roads for LSPOA. The commission has promised to give Scott Burns an estimate by the end of February.

Water Quality-Don Tappan

- Switched lake management company to Savin.
- Water quality issues has driving the increase of the budget numbers.
- Looking for volunteers for maintaining and running the harvester.
- Need to get the sediment trap for inlet 2 cleaned out, need a project manager volunteer for this.
- The biomediation project will continue, the plan may need to be altered due to the dredging project. It appears that this method is working, and perhaps is a good follow up for maintenance after the dredging is done. Don encourages residents to pursue using them for their own privately, if interested.

Old Business:
