Secretary - Kelly Langley - On a motion by Terry Taylor and seconded by Jessica Sirola the minutes from 03/09/23 meeting were approved.

President - Dale Cousino - Dam Project Update - Matt and Rich from Hillsdale County were here to report. The monitoring of the dam has shown concern with increased area and rate of seepage that wasn't there before. Hillsdale County has changed their design to remediate the seepage and stabilize the bank. They've worked with EGLE Dam Safety on this design and they will be submitting it for permitting. This new design will be cheaper and allow for a general contractor to do the job which would speed up the work being done. Current timeline is permitting with the next couple months, bid the work this summer and work completed this fall. The Dam is still stable and being monitored. They are also bidding out the valve repair that is currently not functional, which is a safety concern.

Vice President - Cher-ray Bellingar - Nothing to report.

Treasurers report - Second notice for dues went out and are due May 1st. Kelly made a motion to approve the financial statements, seconded by Terry.

Security - Guards are up and running and all is good.

Parks - Terry Taylor - All contracts have been signed. Clean up on 4/15 at the Main Park from the ice storm damage. Electricity has been restored to the guard shack from the storm damage. Still need to but docks and buoys in. Waiting for LSPOA boat to go in to clean up damage on the island.

Water Quality - Don Tappan - Harvester will be launched on 4/15. Goosebusters was out today for survey of the nests for disrupting eggs. Please destroy any eggs you see from May 1-May 11 or let the office know if you see any. Harvester will be out early again, hopefully with reducing herbicide again this year.
